Dean Kosteas called the meeting to order at 2:00 p.m.

1. Approve Agenda – The agenda was approved.

- 2. Approve Minutes
 - a. December 5, 2023 The minutes were approved.
- 3. New Business
 - a. Curriculog proposals
 - Mathematics, Accelerated Master's BA or BS/MS 1110 Fall 24 Program change
 - Reduce the credit hours from 12 to 9 for double counting graduate coursework towards fulfilling undergraduate (BS or BA) and graduate (MS) degrees.
 - o Approved
 - Physics, Accelerated Master's 1110 Fall 24 Program change
 - The only change to the Physics Accelerated 4+1 BS/MS program is the reduction of the double-counted credits from 11 to 9.
 - Approved
 - Communication, Accelerated Master's BA/MACTM 1110 Fall 24 Program change
 - Change program name: replace "Communication, Accelerated 4+1 BA/MACTM" with "Accelerated Master's in Communication"
 - Limit the maximum number of graduate courses that can be taken as an undergraduate to 9
 - Admission requirement: Replace the cumulative grade-point average of "3.25 or better" with "3.00 or better" and replace a minimum average of "3.25" in COM courses with "3.00" in COM courses.

- Counseling, Chemical Dependency, Graduate Certificate 1110 Fall 24 Program change
 - The certificate program name would be changed from "Chemical Dependency Counseling" to "Substance Use Disorder Counseling."
 - The admissions requirements would be changed to allow for students with a bachelor's degree to enroll in the program. At present, only students with both a bachelor's degree and who are concurrently enrolled in a master's degree program in counseling or social work can enroll in the certificate program.

 - Change 2: Change of exit requirement:
 - a. The exit requirement for the program will be DRE 605, Internship II— Teachers as Leaders successful completion instead of the current options of Comps, Thesis Project.
 - b. DRE 605 is equally rigorous to the current exit requirements that are listed on the Program of Study. In DRE 605, the students are using and applying everything that has been taught in the program, so DRE 605 will and can be their exit requirement.

- Urban Education PhD Admissions Change 1110 Fall 24 Program alteration (no curricular content)
 - The Ph.D. in Urban Education has six specializations (Adult, Continuing and Higher Education; Counseling Psychology; Learning and Development; Policy Studies; School Administration; Teaching Chinese as a Foreign Language). We are proposing changes to the admissions for all specializations other than Counseling Psychology.
 - We propose to make the GRE optional. To gain admission to the program, applicants will need to meet 2 of 4 possible admissions criteria in addition to having a 3.25 GPA in their master's degree (i.e., a thesis or peer-reviewed article, 1 graduate level research methods and 1 graduate level statistics course with Bs or better, or 3 years of professional/volunteer experience, or GRE scores at the 50th percentile or higher). We also added volunteer experience to the third criteria.
 - Finally, we changed the prompt for applicants' personal statements to be more specific in the content of their statements to allow the committee to better understand them as applicants.

4. Graduate Council Representation & Standing Committees

a. There were no update reports to allow time for curriculum proposals and discussion items.



5. Discussion/action items

- a. Graduate Assistants and Health Insurance
 - Graduate Assistant contracts for doctoral students on a full-time contract (20 hours per week of work) with tuition must also include 70% of the cost of single coverage in cases where students have student health insurance through the university.
 - When the contract is fully funded by department/college GA allocation dollars, the cost associated with health insurance coverage will be covered by the College of Graduate Studies using GA allocation dollars set aside by the Graduate Dean. The PI is responsible for covering the cost of health insurance for students funded on grant dollars for any future grants, starting with application dated on or after April 1, 2024. Grants received or applied for prior to this deadline are grandfathered in and the health insurance cost will be covered by the College of Graduate Studies. GAs funded on grants that do not allow for coverage of health insurance will be covered by the College of Graduate Studies.

- b. Deadlines for thesis/dissertation defense and submission of final document to grad studies.
 - In order to ensure timely processing of thesis and dissertation documents and degree posting, students must defend their thesis/dissertation by the end of the 10th week of the semester in fall and spring (end of the 7th week for summer semester) and the final document must be submitted to the College of Graduate Studies for format review by the end of the 13th week of the semester in fall and spring (10th week of summer semester). Exemptions from these deadlines may be granted by the Dean of the College of Graduate Studies in cases where the student's defense is delayed for unexpected reasons outside the student's control.

 - How does the committee evaluate "other" products (e.g. poems, works of visual art, songs, etc.)? Should the application require a letter of support from the department chair commenting on the creative outputs, as is required for PT/adjunct applicants?
