    - **Course Deactivation to Align to Program Changes in Special Education Effective Fall 26 - School of Education and Counseling - Ad Hoc Proposal**
      - Deactivate the following courses: ESE 341, ESE 342, ESE 351, ESE 361, ESE 362, ESE 371, ESE 461, ESE462, ESE471, ESE472, EST 577, EST 578, EST 588

    - **Electrical Engineering, MSEE - 1170 - Fall 26 – Program Change**
      - We propose removing the 600-level course requirements for MSEE students. Specifically:
        - a. For the thesis option, remove the sentence: “The coursework must include at least eight credit hours of 600-level EEC courses.”
        - b. For the course-only option, remove the phrase: “including at least twelve credit hours of 600-level EEC courses.”
        - c. For the project option, remove the sentence: “The coursework must include at least twelve credit hours of 600-level EEC courses.”
        - d. EST 523: Teaching Computer Systems and Structures (3 credits)
