 - Social Work, MSW 1070 Summer 23 Program change
 - o Current Admission Prerequisites for Traditional MSW Program :
 - a. GPA of 3.0
 - b. Minimum of Eight Social Science Courses
 - o Proposed Changes to Prerequisits for Traditional MSW Program:
 - a. Reduce required undergraduate GPA pre-requisite from 3.0 to 2.75 on a 4.0 scale overall.
 - b. Remove requirement for eight social science courses.
 - o Current Catalog Write-up with Proposed Changes (deleted content in bold)
 - a. TRADITIONAL MSW PROGRAM PREREQUISITES
 - b. Students are not required to have a bachelor's degree in social work or any other specific major in order to be considered for admissions to the Traditional MSW program, but they should have earned a bachelors degree. and completed a minimum of eight social science classes prior to admissions. Social science classes include but are not limited to psychology, speech communication, women's studies, political science, gerontology, criminal justice, anthropology, diversity, African American studies, human development, economics, social work, sociology, and urban studies. Student that do not have a minimum of eight social sciences classes may submit a petition with their application materials demonstrating how they have learned commensurate social science content elsewhere.
 - c. The minimum required GPA for admissions to the Traditional MSW program is an overall GPA of **3.0** on a 4.0 scale.

 - a. TRADITIONAL MSW PROGRAM PREREQUISITES
 - b. Students are not required to have a bachelor's degree in social work or any other specific major in order to be considered for admissions to the Traditional MSW program, but they should have earned a bachelors degree.

 - ii. How would you use an anti-oppressive viewpoint as a future social worker and in what ways do you need to challenge your biases/stereotypes?
 - iii. Describe previous social work/human services experience professionally, as a volunteer, or student/intern.
 - iv. Describe one personal experience in which the aim of social justice motivated your actions.
