- 2. Approve Minutes
 - a. February 25, 2021 The minutes were **approved.**

 - a. Faculty Senate
 - Discussion about CSU 2.0 going to vote on if going to have a vote, if so propose vote to occur on April 28, 2021
 - b. University Admissions & Standards
 - Approved 3+3 proposal between Baldwin Wallace and Cleveland-Marshall College of Law
 - c. University Curriculum Committee
 - Communication Sciences and Disorders MA and the Special Education with Licensure MEd went through, we sent another one of the masters in education back to just fix some inconsistencies.
 - d. Graduate Faculty Review Committee
 - 35 applicants reviewed
 - Full time and emeritus faculty with expiring grad faculty status who did not submit applications an email was sent to that group or offering a one-year extension to their Grad faculty status. Those who do not respond/request the one-year extension will be added to the list of those with grad faculty status expiring in the summer. We are not automatically giving the one-year extension, faculty must notify Bill Kosteas.
 - e. Petitions Committee
 - Four petitions reviewed and approved in March
 - Working on updated petitions procedures and once finalized communication will go out to colleges and departments, more information to be provide at next meeting
 - f. Grade Dispute Committee no grade disputes
 - g. Program Review Committee no report

- h. University Research Council Committee
 - 21 GSR applications probably most will be approved
 - Other applications awaiting response to follow-up questions but most will probably be approved. Announcements had not gone out yet.

5. Discussion items

- a. Changes to graduate admissions (see attachment)
 - Conditional admission category eligible students could be conditionally admitted if they have a GPA from 2.25 up to 275. Students must earn a 3.0 in the first semester of course work completing a minimum of six credit hours.
 - Opt-in program if already have 3.0 GPA requirement and are full, do not have to accept conditional admission
 - Provisional admission category allow students to submit unofficial transcripts and register for classes first semester. Students must submit official transcripts in order to register for second semester.
 - Fourth option for regular admission if earned graduate degree student would not have to meet undergraduate GPA requirement. Earned graduate degree proving student capable of successful graduate work.
 - Specific catalog language included in proposal
 - Ultimately these are options available to the programs to be used or not
 - The additional categories will allow tracking by program and student eligibility for financial aid where previously as non-degree this was not available.
 - Programs can have the discretion to add additional conditions
 - The conditional admission (if approved) may need to be changed to a different name
 - Student with conditional admission would be subject to regular dismissal process after the first semester
 - **Approved** (Admissions for Fall 2022)
- b. Elimination of T grades for thesis/dissertation courses (see attached)
 - Proposed change to E and M code grading systems to not include the T grade option
 - Incomplete option can extend if warranted, student would submit petition
 - Kevin Neal to check on financial aid impact with use of T or I grade
 - Amend proposal to include T grade option for use by some for discussion at next meeting
